

Fayette County Sheriff's Foreclosure Sales

All sales are open to the public and will be conducted at the time and date listed on the sale notice at the Fayette County Sheriff's Office, 220 N Industrial Parkway, West Union, IA.

The following condensed and abbreviated list of foreclosures is as accurate as possible, however, does not indicate all the information as printed on the original Notice of Levy and Sheriff's Sale. An actual copy of the Notice of Levy and Sheriff's Sale may be viewed in the Oelwein Daily Register or The Fayette County Union, depending on location of the property for sale, or any of the three public postings, also dependent upon the location of the property for sale:

*Fayette County Courthouse, 1st floor bulletin board located by the engineer's office

*City Hall of the town where the property is located

*Bank or library in the town where the property is located
